Section President Emeritus, **Robert Emerson**, has two chapters in a book on Comparative Law that are to be published in 2024 by Larcier:

- Experts and Lawyering: A Comparative Drive Toward Justice.

Emerson also has two articles to be published in Spring 2024:

- Franchise Electronic Reading and Consent Requirements to Assure Review and Comprehension of Contract Terms, 26 <u>U. Penn. J. Business Law</u> (Issue 1, 2024).

In addition to these publications, Emerson presented the keynote address on the factfinding process in common law and civil law countries at a three-day conference on Comparative Civil Procedure held at Ovidius University in Constanta, Romania, by the Black Sea!

**Lester Reams**, a member of the Editorial Board of the scientific journal, Philosophy of Education, part of the Institute of Higher Education of National Academy of Pedagogical Sciences of Ukraine, recently published an article entitled Fred Fiedler's Contingency Model Revisited: 30 Years Later. Mr. Reams background in psychology, behavioral science, public administration and law with an emphasis in leadership style and leader behavior in all forms of organizations (including law firms, government, and corporations) led him to write the article.

Our Section President, **Thomas M. Madden**, has been busy with a few publications as well. Those include:

President Madden will also be a panelist on Law & Strategy and a presenter on the SEC/ESG paper at the Association Française Droit et Management Congress in Paris in December.

**Mike Schuster** (along with co-authors Tim Samples and Katie Ireland) have written an article entitled *Disclose by Law, Obfuscate by Strategy: A Corpus-Based Analysis of Patent Filings*, which was selected for and presented at Brigham Young University's Law & Corpus Linguistics Conference in October. The article uses textual analysis to evaluate how patentees began to use less readable language in response to changes in the patent disclosure laws. The article will appear in a future issue of the <u>BYU Law Review</u>.

# DID YOU KNOW?

#### What was the original name of ALSB?

The following is a brief history of how the ALSB came to be over 100 years ago! The American Association of Collegiate Schools of Business was founded in 1916. Business law faculty met collectively for the first time at the Association of American Law Schools (AALS) in 1922.

It was at the 1924 Meeting at the American Association of Law Schools held at the LaSalle Hotel in Chicago, a resolution was passed as follows, "That the instructors in Law in Collegiate Schools of Business form and they hereby do form an association to be known as Association of Instructors of Law in Collegiate Schools of Business with the general object of advancing the study and teaching of Business Law and promoting good fellowship among teachers engaged in teaching Business Law."

The name of the organization became the Association of Teachers of Law in Collegiate Schools of Business in 1926 and met for the first time sperate from the AALS in 1928. The organization changed its name again in 1936 to the American Business Law Association (ABLA) in 1936. I would not be until 1991 until the organization changed its name to the Academy of Legal Studies in Business.
