Section to Welcome Tania N. Valdez as Speaker at Conference Breakfast

Please plan to join us at the ALSB Conference Interdisciplinary Section Breakfast on Sunday, August 11, 8:00-9:15 a.m. Our event is tentatively scheduled for the North Carolina Room at the historic Mayflower Hotel in Washington, D.C.

Tania N. Valdez, our featured speaker, is a law professor at the George Washington University Law School and a lawyer engaged in the study and practice of immigration law. She is a graduate of Colorado State University (BA), University of California at Berkeley School of Law (JD), and University of Denver Sturm College of Law (LLM in Clinical Teaching). Her research in the inadequacies of protections for noncitizens in removal proceedings and particularly in the current era of aggressive immigration enforcement has been published in the Notre Dame Law Review and the Washington University Law Review, with also a forthcoming article in the Boston College Law Review.

Prior to joining the faculty at GW Law, Professor Valdez served as a Visiting Assistant Professor and Director of the Immigration Law and Policy Clinic (ILPC) at the University of Denver Sturm College of Law where she supervised law students appearing before the Tenth Circuit Court of Appeals, the U.S. District Court for the District of Colorado, and the immigration agencies. She served as the ILPC's Christopher N. Lasch Clinical Fellow from 2019 to 2021.

Professor Valdez started her legal career as a clinical instructor in the Immigration Unit at Berkeley Law's East Bay Community Law Center. There she represented immigrants living with HIV/AIDS and through a Medical-Legal Partnership with Children's Hospital Oakland. She then served as a staff attorney for the Ninth Circuit Court of Appeals, clerking for the Honorable Magistrate Judge Kristen L. Mix of the U.S. District Court for the District of Colorado. She has litigated civil rights cases in federal and state courts at a boutique law firm located in Denver, Colorado, as well.

ABLJ Call for Essays

The American Business Law Journal is now accepting submissions of *essays*. Essays should offer a focused, nuanced perspective on a legal topic; they may critique current legal debates, ponder future developments, or highlight overlooked areas within broader issues. Essays should be between 7,000 and 10,000 words.

ABLJ will look for a clear argument and logical progression. Essays should be well-researched and include persuasive critical analysis, offering an original viewpoint and an insight into a current legal issue that will advance the field and contribute to the existing literature. While still scholarly, essays may adopt a more conversational or persuasive tone than full length articles. Authors should still adhere to the Harvard Bluebook and our existing style guidelines for submissions, but have more leeway to express personal viewpoints.
